SCHOLARSHIP FUND

This will be the last issue of the PATCH before our Reunion at the Carillon Hotel in Miami Beach Florida. The hotel management reports a very good return of the reservation cards they sent to all of our members. If you have not as yet made your reservation you had better do so soon.

The Carillon is providing special low rates to Raiders and their guests for this occasion. For double occupancy, the rate is \$6.00 per day per person or, better yet, \$9.00 per day per person on the modified American Plan which includes breakfast and dinner. There will be no room charge for children under twelve, and \$3.00 for children over twelve in the same room as their parents. Single rooms will be \$10.00 per day with the same \$3.00 charge for meals if desired.

The registration fee this year is going to be \$18.50 per family. For children over twelve attending the banquet, there will be a charge of \$2.75 each. Children under twelve will be free. Single registrations will be \$10.00.

### RAIDER CREATES MOSAIC

Jacques Berbesque, 3rd Bn., took more than 5,000 tiny bits of glass tile in varying shades of 20 colors. He used a design drawn in pastels by a Chicago artist. He applied the skill of 15 years work as a ceramic tile contractor and artist, plus 400 hours of spare time effort over two years.

Now the wall of the Brothers' Oratory Chapel of the Capuchin Catholic Seminary of St. Mary near Schererville, Ind., is adorned by a large mosaic depicting St. Francis of Assisi serving mass.

Berbesque, who operates a commercial tile firm at 2310 Ridge Road, Gary, Indiana, donated the mosaic to the seminary. Tho he is not Catholic, he had become acquainted with the fathers and brothers of the order while doing tile work several years ago for their new seminary. The Rev. Bartholomew Kestell, Supervising Architect, had seen examples of Berbesque's Mosaics and commissioned him to do a mosaic for the chapel. Berbesque accepted but would take no pay.

The work is six feet high, eight feet wide, and in three panels. Each piece of glass tile was cut and set separately. Berbesque's wife, Betty, also an artist, correlated the colors from the original sketch to the mosaic tile. The work weighs 300 pounds.

The seminary is in a secluded area off U.S. Highway 39, 4 miles north of Crown Point. The buildings were built in 1958-59. The seminary has a student body of 74 young men studying philosophy in preparing for the priesthood. The Capuchin Order, one of three Franciscan Orders, works in home and foreign missions.

The following letter is one of many that we received in answer to our "help" letter. We feel this letter may be typical of some of the gripes against the organization. We will try to answer these to your satisfaction.

Gentlemen:

Please note enclosed check for \$10.00. If my dues are paid, the ten is yours, if they are not paid, pay them and keep the balance.

Now that the cash business is out of the way, I feel entitled to call a spade a spade.

Have you ever felt that as a dues paying member to a non-profit organization, someone might like to have a look at a financial statement of some kind once in a while? On the letterhead paper which your appeal for money and dues was written, you listed eighteen names; ten of those names listed was accompanied with an Illinois Address.

Hell, look it over. Every Raider wasn't from Chicago or necessarily Illinois. You are wanting to draw members and ex-members back into the group for a healthy organization, but it seems from an outsider's viewpoint that it is becoming more and more of a closed corporation.

Sure, I am a great one to talk because I have never attended the reunion. Why? Either the time wasn't right or the finances were on the down side.

However, I am quite sure that my case isn't the only one such as this. My personal feeling is that there is lots of Ex-Raiders that are in the same boat. This being the case and knowing that there would be more attending a reunion if it were more centrally located, why not pick a spot that would be more centrally located for Ex-Raiders from all over the country.

This letter is not meant to be just one big long criticism. I believe in the Raider Association. I believe in the people that made it possible. I would love to see some of my old buddies again. I would like very much to hear from my old C.O., Capt Sheffield or my Platoon Leader, Lt. Mims.

These have been suggestions, thoughts and criticism. No offense meant or implied.

Dear Raiders:

This is not anything like a closed corporation of just Chicago people. The organization was formed originally on the West Coast, and the National Headquarters was there for a number of years. They worked very hard to build up this organization. When they finally wanted a rest, the Midwest Chapter was the only group able to handle the National Headquarters at that time. The reason most of the officers are from Illinois is that we have to be close enough to get together to iron out problems and make decisions.

We have local chapters in NORTHERN CALIFORNIA (Frank Gilbert, 220 Poplar, Millbrae, California, President), LOS ANGELES (Paul Aspel, 6238 W. 85th Place, Los Angeles, President), SOUTHWEST (Cullen Barnett, 1403 Scarborough, Pasadena, Texas, President) and MIDWEST (Nick Barach, 12120 S. Ada, Chicago, President). Anyone wishing to organize a chapter in his own area will get all of the help that the National Headquarters can give them.

The success of a reunion depends upon the work of the Raiders in the area of the reunion. We have learned from experience that at times Raiders with a lot of enthusiasm have asked for a reunion in their area, but when it came time for all of the labor involved, these people were not around and all of the work fell upon one or two raiders.

This is why we have to try and put the reunion in a location where we can be reasonably sure we will have some local help.

This is your organization, and anytime you have a gripe, we want to hear it. We are trying to do a job that may be unfamiliar to our everyday life and, therefore, we make mistakes, but they are honest mistakes, and we have to answer to you members at all times.
